Coke Battery Performance – Method 303

Performance Review – Daily (Q4 2025)



Date	Doors (% Leaks)	Lids (% Leaks)	Off-takes (% Leaks)
2015 Thresholds (July 2 start)	54%	2%	NA
2016 Thresholds	32%	2%	NA
2017-2019 Thresholds	10%	2%	5%
2020 - 2025 Thresholds	5%	1%	4%
Oct – Dec 2025 Range (Average)	0 – 4.44% (1.73%)	0 – 0.8% (0.23%)	0 – 2.6% (0.35%)

Daily Measurements Performed in Q4

- All weekdays, except for holidays
- 6 Saturday (10 Saturdays for 2025 year)
- 3 Sundays (10 Sundays for 2025 year)

Oct – Dec Operational Adjustments

- None required

Performance Review – 30-Day Rolling Avg. (Q4 2025)

2015 Limits (July 2 start)	38%	0.8%	25%	12 sec
2016 Limits	22.5%	0.8%	15%	12 s
2017-2019 Limits	7%	0.8%	4.2%	12 s
2020 - 2025 Limits	4%	0.4%	2.5%	12 s
Oct - Dec 2025 Range (Average)	1.53 – 2.05% (1.75%)	0.18 – 0.27% (0.23%)	0.08 – 0.59 % (0.26%)	5.39 – 6.99s (6.06 s)

Performance Review – Daily Observations (Q4 2025)



Date	Pushing Emission (opacity %)
2015 Threshold (July 2 start)	$\geq 50\%$
2016 – 2018	$\geq 50\%$
2019	$\geq 40\%$
2020 – 2025	$\geq 30\%$
Oct - Dec 2025 Range (Average)	0 – 27.5% (4.72%)

 - December 27, 2025 (13:30)
 - Operational issues encountered during oven charging
